18 on August 24, 2021;
- 19 • Replies on motions for summary judgment and Daubert motions shall be filed on
20 August 31, 2021; and
- 21 • **A hearing on motions for summary judgment and Daubert motions shall be**
22 **held at 2:00 pm on Tuesday, ~~September 14, 2021~~. September 21, 2021**
